Tony Edwards	We are continuing to have a service delivery function and use of a lounge space at Tottenham Court Road . We no longer have dedicated office space.
2	What is the underlying cause of the reduced income in the past year? Is it dropping membership, less job adverts, less sponsorship etc?	Paul Reynolds	Membership has remained static. The drop is in commercial income and we have been prioritising redressing this. Jonathan will be leading this work

I can confirm that following the publication of the new Charity Commission guidance the Board approved a new meeting policy and process in September this year which can be found on the AGM page on our website. It sets out that General Meetings may be held in any format as determined by the Board for each event.

Simon Cramp	From a financial perspective we are on target for achieving our reduced deficit of £100k. This has been achieved by oversetting the reduction in income with reduced expenditure. We are on target with most of priorities for the year which have mainly been foundation building. Our two new Director will help us to elevate our impact going forward. I have recently published an update on the website (add link) and would encourage you to look at the detail. I am really pleased with the progress we have made.

Simon Cramp	At the moment Belinda is getting out and meeting as many people as possible (e.g. TCPA, RTPI, Learning through Landscapes) and doing some broad stakeholder mapping. When the Board has agreed priorities we will do some detailed power mapping and target particular stakeholders.
20	It would be good to understand which stakeholders the LI is concentrating on.	Henry Penner	We will be able to give a comprehensive answer next year.
21	If the LI is open and transparent, why are the Board minutes not published promptly? When I looked recently, were no Board minutes since December 2023?	Helen Tranter	Trustee meetings and their discussions are confidential. However when a decision has been reached by the Board as a whole that decision is reported to members with a clear explanation of the reasons for that decision. This is how we ensure every member receives the same information and explanation. It is for that reason that an update from the Chair of the Board following each Board meeting is now being published/circulated, giving an outline of key decisions made and the context around what was considered by the Board in reaching those decisions. This update is circulated to all members and is available on the website. A similar report is also being circulated by the President after each Council meeting. The Board feel this is a much clearer, and more accessible way of communicating the outcomes of Board meetings to members.
22	Are there any plans for a mutual recognition agreement between UK and US & Australia for chartership? Or at least for the LI to recognise accredited university degrees from those countries? RIBA has a mutual recognition agreement with the US, Australia, and New Zealand.	Miza Moreau	We do have recognition of overseas' programmes for Associate Membership. There is reciprocity arrangement in place with IFLA organisations but we carry out additional scrutiny to safeguard our standards. Historically we have had people with degrees and experience in other countries join the pathway at the right level.

23	Landscape Planning is the main growth area in the job market. There are not enough landscape planners. We need many many more. There is no clear academic route currently. So the LI has a reasponsibility for how we are going to increase numbers in this area. It is a completely different profession to design and it is important that the LI recognises its importance. Masterclasses, training, sharing good practice etc is needed. The LI hasnt a good record in this area and this MUST improve	Mike Spence	We raise this at every meeting with Government and other professions. We are working hard to influence the government planning agenda to ensure that landscape is maintained as a key part of the planning system and why we came up with our asks of government prior to the election and have submitted a comprehensive response to the NPPF review. It is also the central theme of the Jellicoe Lecture at the end of November this year. The Education & Membership Committee is also looking at landscape planning and looking at changing from full accreditation to Landscape Approved Courses to widen our net and reach more people to bring more people into the profession more quickly. 24	Please can we see all others attending this meeting	Edward Hutchison	We used a specialist AGM meeting platform which enables members to access the meeting and interact through, raising of hands and a Q&A feature as well as vote securely. It is a system used by a wide range of membership organisations and charities because it enables more members to participate and vote wherever they are with no need to travel. I don't know if you watched the National Trust AGM this year but they used a similar system and members questions were read out by the facilitator and there was no ability for members participating remotely to speak. There is currently no system that can support so many members using their camera facility.
25	How much is the LI paying MERL for our archive and is this going to be increased as we get nearer to the LI centenary	Tony Edwards	We make an annual donation to them of £10,000. We will be working closely with FOLAR and MERL in the leadup to our Centenary to develop a plan to deliver what we want to achieve from the centenary. We still have to consult on what we want to achieve from the centenary but we will want to look forward to the next 100 years as well as respect and cherish our incredible history.
26	It was sad to hear that Karen is leaving the LI - she has been a brilliant contact point for the branches - something lacking for a long time. Can you confirm if she is being replaced, or if someone else will be picking up this key role as a liaison between branches and the LI Office?	Paul Reynolds	Yes we are sorry to see her leave us. We will be recruiting to this role which is critical to the interface with branches specifically and members more widely. In the meantime, the team will make sure that we provide continuity in that service to branches.

We do have a Level 7 programme but it is not yet supported by an educational institution

	Questions asked in advance				
1	The volume of investments and assets of the Institute seem to show significant increase. It unclear how these investments are structured. In line with other Charitable bodies would the Institute consider agenda for publishing based on independent advice on financial policy, an Ethical and equitable charitable investment policy, to be devised?	Adam Cook	The current investment policy was updated and approved by the Board this year and includes a section on Ethical and Sustainable Considerations. This policy will be published on our website and do please get back to us once it is if you have any further questions. In addition, we have significant internal guidance around our investment and the Board has ensured our investment manager has strong ESG credentials which are applied for the benefit of the LI's assets. However, the value of the LI's investments is not sufficient to warrant a bespoke mandate		
2	Could the Institute consider adding agenda for a transparent ethical standard in a code of conduct of practice and research?		Yes this will certainly be considered as a part of the review of the Code of Practice that is to be undertaken next year.		
3.1	I put this question to the 2023 AGM and received an unsatisfactory answer. Please could I have a specific and numerical answer: "2023 LI Awards: what were the costs of mounting the event and what was the revenue from holding the event?". Please also give the figures for the 2024 LI Awards	Tom Turner	The next Awards Ceremony will take place in the Autumn of 2025 while we take time to review all the different feedback we have received from members and come forward with future options thereafter. What I can say on the cost is that the 2025 ceremony will be cost neutral.		
3.2		Tom Turner	We have taken advantage of a break in the lease of the offices in Tottenham Court Road to close them and to take the opportunity to review our future requirements for office and meeting space in light of changing ways of working and communication. The review will take into account feedback from members on their needs. There are lots of different exciting options and I am confident that we can find a solution which will reflect our values and meet our requirements across the UK. While this review is underway we will be retaining our registered office and a service hub at Tottenham Court Road and our staff team will be working remotely temporarily with frequent team meetings organised.		
3.3	I put this request to the 2023 AGM and received an unsatisfactory answer. Please will you (1) set out how the LI Corporate relates to the Royal Charter Objectives (2) define how the objectives will be "identifiable and capable of being proved by evidence" (3) have an open discussion with the membership, both online and offline, to consider alternatives and discuss their costs, benefits, merits and drawbacks.	Tom Turner	The future structure of our Strategy will be for the Board to decide early in 2025 in light of all the feedback from members and stakeholders it has sought. You will have already seen our commitment to prioritising our core objectives of membership and professional standards and education and careers going forward and that will be at the heart of our refreshed strategy. The Board will also be agreeing key performance indicators and these will enable members to monitor delivery against our commitments.		

4	Given that the LI's Skills surveys have identified the need to promote a wider, more diverse membership and to encourage early career landscape architects to take up chartership (and that members subscriptions bolster resources), should the Landscape Institute consider adopting the RIBA's model for Registered Practices? This requires (as below): - at least one full-time principal to be a chartered member; - at least one in eight of all staff to be chartered members; and - all work to be supervised by a chartered member. (Currently the LI requirement seems to be the same for a practice of 2 people, as for a practice of 100s).	Lucy Jenkins	This is an interesting idea. I am aware that the Registered Practices scheme has been under review for some time. As part of the work to refresh the member value proposition for individual members and for Registered Practices that I am picking up, we will looking closely at the routes to membership, and exploring ways to promote a wider and more diverse membership. We will also be looking at ways to promote the pathway to chartership.
5	I would like to know why the LI doesn't celebrate new CMLI members in anyway whatsoever. No ceremony, certificate or even a website post. I became a CMLI in June and on request I was sent a pdf of my certificate and told it would cost £20 for a hard copy. This hardly endears new members to the LI and yet the LI needs all its members both to engage with it and for their fees. Please can the LI rethink it's policy on this?	Clare Birbeck	Thank you for raising this really important point. This has been raised by others and reinforces how important it is for us to recognise the commitment and hard work it takes to reach CMLI status. Therefore I can confirm that we will be reviewing how we do this and how this is acknowledged.
6	My question is the following. Why did you stop sending out certificates to cmli's when they are elected as chartered members? When I was elected as a chartered member there was a linkedIn post and not even a mention on the LI website. Don't you think that this is at odds with your new behaviour policy which is articulated in the following six points? 1. Mutual respect and courtesy 2. Active participation and collaboration 3. Ethical behaviour 4. Feedback and contribution 5. Celebrate achievements 6. Adherence to policies and guidelines And part of the reason people feel disengaged with the Institute? I understand the need to be sustainable and not waste paper. However people work very hard to achieve this status and it means a lot to them so they would like a certificate. I have caught up with key people this morning and you have made some very valuable reflections that have highlighted how important it is for us to recognise the commitment and hard work it takes to reach CMLI status. 7	What progress has been made on replacing the website / improving P2C and CPD records ?	Daniel Stewart Smith	This is part of Project Kestrel to deliver our new digital home. Work is progressing and is on track for going live autumn 2025. Unfortunately that means issues with the current website and our on-line processes will continue to as is until then.
